### ORCHESTRA MUSICIAN SOLO - trumpet - permanent cooperation

which will be held on April 16, 2025 at the headquarters of the W-M Filharmonia.

To meet the expectations of the market, we are looking for talented, active and ambitious people for the project "Trumpet - permanent cooperation" with the prospect of transition / extension of the form of employment to a contract of employment. Taking into account the various commitments of the student period, we give you a chance to try your hand in a large, experienced team, cooperation at the highest level.

\* Requirements include the ability to play the piccolo trumpet. The ability to play the natural trumpet is also welcome.

### Detailed information

The relevant application, together with an artistic curriculum vitae and a RODO clause (attached), should be submitted by April 6, 2025 to: [inspektor@filharmonia.olsztyn.pl](mailto:inspektor@filharmonia.olsztyn.pl) or by regular mail to the address of the Warmian-Masurian Philharmonic. The postmark date is decisive. Application documents must be signed - traditionally or electronically.
2. The content of the application should include a clause that reads:  
I consent to the processing of my personal data by the Warmia and Mazury Feliks Nowowiejski Philharmonic in Olsztyn for the purposes necessary for the recruitment process - in accordance with the Act of May 10, 2018 on the Protection of Personal Data (i.e. Journal of Laws of 2019, item. 1781) and in accordance with the Regulation of the European Parliament and of the Council (EU) 2016/679 of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) - RODO.
3. Application documents: application and RODO clause that do not include consent to the processing of personal data and unsigned will not be considered.
4. Documents delivered after the deadline will not be considered.
5. Each candidate will receive confirmation of submission of documents via email.

6. Selected candidates will receive by e-mail an invitation to participate in the competition audition by April 11, 2025.
7. The auditions will be held on April 16, 2025 at the premises of the Warmia and Mazury Philharmonic in Olsztyn. The Philharmonic provides an accompanist. Rehearsals with the accompanist will be arranged on an individual basis.
